EACH BIOGEN REVITALYTE 5 g POWDER SACHET CONTAINS:

Sodium (as chloride) 415 mg, Potassium (as chloride) 200 mg, Ascorbic acid (Vitamin C) 200 mg, Calcium (as carbonate) 150 mg, Magnesium (as oxide) 100 mg, L-cysteine (as N-acetyl-L-cysteine) 100 mg, Pyridoxine (Vitamin B6)(as HCl) 2 mg, Manganese (as sulphate) 1 mg, Cyanocobalamin (Vitamin B12) 20,000 µg.

BIOGEN REVITALYTE is available without a doctor's prescription, for you to maintain your health. Nevertheless, you still need to use BIOGEN REVITALYTE carefully to get the best results from it.

- Do not share BIOGEN REVITALYTE with any other person.
- Ask your healthcare provider or pharmacist if you need more information or advice.

1. What BIOGEN REVITALYTE is and what it is used for

BIOGEN REVITALYTE, supports hydration, electrolyte balance, and recovery by replenishing essential minerals and vitamins. Promotes energy metabolism, antioxidant protection, and overall cellular health.

2. What you need to know before you use BIOGEN REVITALYTE

Do not use BIOGEN REVITALYTE:

- If you have a hypersensitivity to any of the ingredients or the excipients listed in 6.1.
- Not recommended for use in children under the age of 18 years.
- Do not use this product with other potassium-containing supplements or with potassium-containing salt-substitutes.

Warnings and precautions

Not to be used in cases of dehydration as a substitute of an oral rehydration solution. Consult with a healthcare provider prior to using BIOGEN REVITALYTE, especially if you have a medical condition. Use BIOGEN REVITALYTE with caution:

- Consult a healthcare provider prior to use if you are pregnant, or breastfeeding.
- Increased sodium intake has been associated with worsening of the following conditions: osteoporosis, multiple sclerosis, cardiovascular disease, hypernatremia, hypertension, kidney disease with proteinuria. Patients should be advised to consume sodium in moderation.
- Kidney disease affects potassium excretion and increases the risk of elevated potassium levels. Caution should be advised for those with kidney disease (including chronic kidney disease), kidney failure or post-kidney transplant.
- The co-administration of calcium salts or thiazides may lead to developing hypercalcaemia. When indicated, serum calcium, phosphate, alkaline phosphatase, liver function tests and magnesium should be monitored.
- Use with caution in patients with established osteoporosis.
- Magnesium supplements can increase the risk of hypermagnesemia in those with reduced or impaired kidney function.

Children and adolescents

The safety and efficacy of BIOGEN REVITALYTE in children and adolescents has not yet been established. Not recommended for use in children under the age of 18 years.

Other medicines and BIOGEN REVITALYTE

Always tell your healthcare practitioner if you are taking any other medicine (this includes complementary or traditional medicines). Not all possible interactions with other medicines may be included in this leaflet. Consult a healthcare practitioner prior to use. Always consult a healthcare provider before use, especially when taking medications for chronic conditions.

BIOGEN REVITALYTE can interact with the following medications:

- Antihypertensive medications: High sodium intake can reduce plasma lithium levels by increasing its excretion. Patients taking lithium should avoid large fluctuations in sodium intake.
- Antibiotics and osteoporosis medications: Calcium and magnesium may reduce the absorption of bisphosphonates, tetracyclines, quinolones, and gabapentin. Calcium carbonate may also decrease the effectiveness of levothyroxine in hypothyroid patients and reduce the absorption of sotalol, potentially impacting its effectiveness.
- Antioxidant and neurological medications: Magnesium may reduce the bioavailability of levodopa, affecting Parkinson's treatment.
- N-acetyl-L-cysteine may enhance the effects of nitroglycerin, possibly causing excessive vasodilation and hypotension. Vitamin B6 may also reduce levodopa effectiveness by increasing its metabolism.
- Endocrine medications: Calcium carbonate may reduce the absorption of levothyroxine, which could impact thyroid hormone levels.
- Vitamins, minerals and nutrients obtained from other sources should be taken into account when prescribing / suggesting BIOGEN REVITALYTE.

Pregnancy, breastfeeding and fertility

Safety in fertility, pregnancy and lactation has not been established. If you are pregnant and breastfeeding, think you may be pregnant or planning to have baby, please consult with your doctor, pharmacist, or other healthcare provider for advice before taking this medicine.

Driving and using machines

No studies on the effects on the ability to drive or use of machinery have been performed. Patients should exercise caution before driving or using machinery until they are reasonably certain that BIOGEN REVITALYTE does not adversely affect their performance.

3. How to take BIOGEN REVITALYTE

Do not share medicines prescribed to you with any other person. Do not exceed the daily recommended dosage. Always use BIOGEN REVITALYTE exactly as described in this leaflet or as your healthcare practitioner has instructed. Check with your healthcare provider if you are not sure.

If you take more BIOGEN REVITALYTE than you should:

In the event of an overdose, consult your doctor or pharmacist. If neither of these is available, contact the nearest hospital or poison control center.

Take this information sheet and the container with the remaining BIOGEN REVITALYTE with you, so that the doctor can see what you have taken.

If you forget / neglected a dose of BIOGEN REVITALYTE:

Do not take a double dose to make up for forgotten individual doses.

Adults 18 years and older:

Dissolve 1-2 sachets in 500 ml of water and drink daily, or as recommended by a healthcare professional.

Ideal for use during intense physical activity and recovery.

4. Possible side effects

BIOGEN REVITALYTE can have side effects.

Not all side effects reported for BIOGEN REVITALYTE are included in this leaflet. Should your general health worsen or if you experience any untoward effects while taking BIOGEN REVITALYTE, please consult your healthcare provider for advice.

If any of the following happens, stop using BIOGEN REVITALYTE and tell your doctor immediately, or go to the casualty department at your nearest hospital:

- Swelling of the hands, feet, ankles, face, lips and mouth or throat, which may cause difficulty in swallowing or breathing,
- Rash or itching,
- Fainting.

These are all very serious side effects. If you have them, you may have had a serious allergic reaction to BIOGEN REVITALYTE. You may need urgent medical attention or hospitalisation.

Tell your doctor immediately or go to the casualty department at your nearest hospital if you notice any of the following:

- Chest pain,
- Angina,
- Changes in the way your heart beats, for example, if you notice it beating faster,
- Difficulty breathing,
- Signs of recurrent infection such as fever or sore throat,
- Less urine than is normal for you,
- Yellowing of the skin and eyes, dark urine, and tiredness which may be symptoms of liver problems.

These are all serious side effects. You may need urgent medical attention.

Tell your doctor if you notice any of the following:

Common / Frequent side effects:

- Nausea,
- Abdominal cramps or stomach pains,
- Headache,
- Dizziness,
- Tiredness.

Uncommon / Less frequent side effects:

- Dry cough,
- Muscle cramps,
- Flatulence or wind,
- Diarrhoea,
- Loss of appetite.

If you notice any side effects not mentioned in this leaflet, please inform your doctor or pharmacist.

Reporting of side effects

If you get any side effects, talk to your doctor or pharmacist. This includes any possible side effects not listed in this leaflet. You can also report side effects to SAHPRA via the "6.04 Adverse Drug Reaction Reporting Form", found online under SAHPRA's publications: <https://www.sahpra.org.za/Publications/Index/8>.

By reporting side effects, you can help provide more information on the safety of BIOGEN REVITALYTE.

5. How to store BIOGEN REVITALYTE

- Protect from moisture and store at or below 25 °C.
- KEEP OUT OF REACH OF CHILDREN.
- Do not use after the expiry date stated on the label.
- Return all unused BIOGEN REVITALYTE to your pharmacist.
- Do not dispose of unused BIOGEN REVITALYTE in drains or sewerage systems (e.g. toilets).

1. Wat is BIOGEN REVITALYTE en waarvoor word dit gebruik

BIOGEN REVITALYTE, ondersteun hidrasie, elektrolytbalans en herstel deur noodsaklike minerale en vitamiene aan te vul. Bevorder energiemetabolisme, antioksidantbeskerming en algehele sellulêre gesondheid.

2. Wat jy moet weet voordat jy BIOGEN REVITALYTE gebruik

Moenie BIOGEN REVITALYTE neem nie:

- Indien u 'n hypersensitiviteit het vir enige van die bestanddele of die hulpstowwe gelys in 6.1.
- Nie aanbeveel vir gebruik by kinders onder die ouderdom van 18 jaar nie.
- Moenie BIOGEN REVITALYTE saam met ander kaliumbevattende aanvullings of kaliumbevattende soutvervangers gebruik nie.

Waarskuwings en voorsorgmaatreëls

Moenie gebruik word in gevalle van dehidrasie as 'n plaasvervanger van 'n mondelinge rehidrasie oplossing. Raadpleeg 'n gesondheidsorgpraktisyn voordat u BIOGEN REVITALYTE gebruik, veral as u 'n mediese toestand het. Gebruik BIOGEN REVITALYTE met omsigtigheid:

- Raadpleeg 'n gesondheidsorgverskaffer voordat jy hierdie produk gebruik as jy swanger is of borsvoed.
- Verhoogde natrium-inname is gekoppel aan die verergering van die volgende toestande: osteoporose, veelvuldige sklerose, hartsiektes, hiperaartremie, hipertensie, niersiekte met proteinurie. Pasiënte moet aangeraai word om natrium met matigheid te gebruik.
- Niersiekte beïnvloed kaliumuitskeiding en verhoog die risiko van verhoogde kaliumvlakte. Omsigtigheid word aanbeveel vir diengene met niersiekte (insluitend chroniese niersiekte), niertransplantasie of niertransplantasie.
- Die administrasie van kalsium soutie of tiasiede kan lei tot die ontwikkeling van hiper kalsiemië. Waar nodig, moet serumkalsium, fosfaat, alkaliese fosfatase, leverfunksietoets en magnesium gemonitor word.

Die neem van BIOGEN REVITALYTE en ander medisyne

Lig altyd u gesondheidsorgpraktisyn in indien u enige ander medisyne neem (dit sluit aanvullende of tradisionele medisyne in). Nie alle moontlike interaksies met ander medisyne word in hierdie pamflet ingestul nie. Raadpleeg 'n gesondheidsorgpraktisyn voor gebruik. Raadpleeg altyd 'n gesondheidsorgverskaffer voor gebruik, veral wanneer u medikasie vir chroniese toestande neem.

BIOGEN REVITALYTE kan interaksie hê met die volgende medisyne:

- Antihypertensiëwe medikasie: Hoë natrium-inname kan die plasma-litiumvlakte verminder deur sy uitsteekding te verhoog. Indien jy litium gebruik, word dit aanbeveel om groot fluktusies in natrium-inname vermy.
- Antibiotika en osteoporose medikasie: Kalsium en magnesium kan die absorpsié van sekere medikasie, insluitend bisfosfonate, tetrasikline, kinolone en gabapentin, verminder. Kalsiumkarbonaat kan ook die effektiwiteit van levotiroksien in mense met hipotiroïdisme verminder en die absorpsié van sotalol beïnvloed, wat moontlik die werking daarvan kan verlaag.
- Antioxidant en neurologiese medikasie: Magnesium kan die bio-beskikbaarheid van levodopa verminder, wat die behandeling van Parkinson beïnvloed.
- Antikoagulant en neurologiese medikasie: Magnesium kan die absorpsié van levotiroksien verminder, wat die tiroïdormoonvlakte kan beïnvloed.
- Endokriene medikasie: Kalsiumkarbonaat kan die absorpsié van levotiroksien verminder, wat die tiroïdormoonvlakte kan beïnvloed.
- Vitamene, minerale en voedingstowwe wat uit ander bronne verkry word, moet in ag geneem word wanneer BIOGEN REVITALYTE voorgeskrif of voorgestel word.

Swangerskap, borsvoeding en vrugbaarheid

Veiligheid in vrugbaarheid, swangerskap en laktasie is nie vasgestel nie. Indien jy swanger is en borsvoed, dink jy dalk dat jy swanger is of beplan om 'n baba te hê, raadpleeg asseblief jou dokter, apteker, of ander gesondheidsorgverskaffer vir advies voordat jy hierdie medisyne neem.

Bestuur en die gebruik van masjinerie

Geen studies is uitgevoer oor die effek op die vermoë om te bestuur of die gebruik van masjinerie nie. Pasiënte moet versigtig wees voordat hulle bestuur van masjinerie gebruik, totdat hulle redelik seker is dat BIOGEN REVITALYTE nie hul werkverrigting nadruklik beïnvloed nie.

3. Hoe om REVITALYTE te gebruik

Moenie medisyne wat aan u voorgeskrif is met enige ander persoon deel nie. Moenie die aanbeveelde daaglikske dosis oorskry nie. Gebruik BIOGEN REVITALYTE presies soos aanbeveel in hierdie inligtingsblad, of soos aanbeveel deur u gesondheidsorgpraktisyn. Raadpleeg u gesondheidsorgpraktisyn indien u nie seker is nie.

Indien u meer BIOGEN REVITALYTE neem as wat u behoort:

In die geval van 'n oordosis, raadpleeg u dokter of apteker. Indien nie een van hulle beskikbaar is nie, kontak die naaste hospitaal of gifsentrum.

Neem hierdie inligtingsblad en die houer met die oorblywende BIOGEN REVITALYTE saam met u, sodat die dokter kan sien wat u geneem het.

Indien jy vergeet / negelaat het om 'n dosis BIOGEN REVITALYTE te neem:

Moenie 'n dubbele dosis inneem om vergeet individuele dosisse te vergoed nie.

Volvassenes 18 jaar en ouer:

Los 1-2 sakkies op in 500 ml water en drink daagliks, soos aanbeveel deur 'n gesondheidswerker. Ideaal vir gebruik tydens intense fisiese aktiwiteit en herstel.

4. Moontlike newe-effekte

BIOGEN REVITALYTE kan newe-effekte hê.

Nie alle newe-effekte wat vir BIOGEN REVITALYTE gerapporteer is, word in hierdie inligtingsblad ingesluit nie. Indien jou algemene gesondheid verswak of indien jy enige ongunstige effekte ondervind terwyl BIOGEN REVITALYTE geneem word, raadpleeg asseblief jou gesondheidsverskaffer.

Indien jy enige van die volgendeervaar, hou op om BIOGEN REVITALYTE te neem en sê dadelik vir jou dokter of gaan na die ongevalle-afdeling by jou naaste hospitaal:

- Swelling van jou hande, voete, enkels, gesig, lippe en mond of keel, wat probleme kan veroorsaak met sluk en asemhaling;
- Uitslag of geuje;
- Floute.

Hierdie is baie ernstige newe-effekte. Indien jy dit het, mag jy 'n ernstige allergiese reaksie op BIOGEN REVITALYTE gehad het. Jy mag dringende mediese bystand of hospitalisasie benodig.

Sê so gou as moontlik vir jou dokter indien jy enige van die volgende opmerk:

- Borspny,
- Angina,
- Veranderings in die manier waarop jou hart klop, byvoorbeeld, as jy dit vinniger klop,
- Moeilikhed met asemhaling,
- Tekens van herhaalde infeksies soos koers of seer keel,
- Minder urin as normaal vir jou,
- Vergeling van die vel en oë, donker urine, en moegheid wat simptome van lewaterprobleme kan wees.
